



2026 Student Financial Aid Program of Musashino City

Thank you for your continued understanding and cooperation in the educational administration of Musashino City. This is the financial aid for annual payments incurred by guardians to school such as school supplies and extracurricular activities fees.

You can apply to see whether you are eligible to receive it. For more detail, please see our website

Period of application May 31 (Sun) (Postmark valid)

Applications are required annually !

Submit your application by May 31 and if approved, you can receive the payment from April. You can apply after the deadline, but receive only part of it for the remaining period after the approval.


Eligibility criteria to receive the financial aid

Financial aid is available to the students who live in Musashino City, attend public and national elementary or junior high school, and have one of the following financial situations.

*We cannot accept pre-screening.

- ① **Annual income (income of 2025) of all household members is lower than the designated maximum sum.** *Standards: Refer to the back.
- ② **Household receiving Child Support Allowance.**
*Child allowance and child training allowance is different.
- ③ **Household on welfare (including one whose aid will be discontinued within the year 2026)**
- ④ **Household coping with unemployment, illness, etc. and annual income in 2026 is applicable to ①.**

How to apply for the financial aid program

 For online application, only the bank account in the applicant's name can be used as the transfer destination.

2. Fill in the application form, use the application envelope and post it in the mail box. (No stamps are required), or submit it to the Educational Consulting & Support Section (South Bld. of the City Hall, F5)

 If you moved into Musashino City after Jan. 2nd, 2026 and apply for the financial aid according to eligibility ①, please submit the taxation certificate or exemption certificate issued by the municipality where you live as of Jan. 1st, 2026

If you cannot get the taxation certificate before the deadline (May 31), please submit the application first, and submit the taxation certificate as soon as possible.

*If you are salaried, the total amount of salary is the one after deduction of employment income on tax certificate slip. If you have completed a tax return, the total amount of salary is the one after subtraction of necessary expenses from total income

*The above table is a rough estimate, and the standard amount to be certified will vary depending on household composition, age and other factors.

*Please understand we are unable to answer whether you can be certified or not in advance.

Can we apply for the financial aid even if we are not sure we are eligible or not?

Yes, you can. Please notify that your total amount of all household members' is lower than the designated maximum sum.

Do we have to pay school lunch fees after the approval?

No, you don't. You don't have to pay school lunch fees as they are free of charge at every public school in Musashino city..

How do we pay for other school supply fees after the approval?

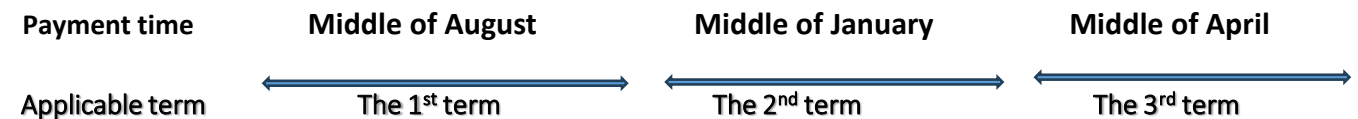
You need to pay for other school expenses despite the approval date (before or after the approval) as instructed by the school. The amount of money covered by the aid will be paid back after each term. If the study payment required by your school has been unpaid, the financial aid payment will be transferred to your school bank's account.

When can we receive the decision if the application is granted?

The decision to grant financial aid will be mailed directly to you at the beginning of July if you apply before May 31st.

When can we receive the payment if the application is granted?

You will be able receive the payment after the end of each semester.

The decision to grant financial aid will be mailed directly to you from the Musashino City Board of Education. The personal information is strictly kept at school.

Financial Aid for estimated annual payment

- School lunch fee (About ¥50,000 a year)
- School trip fee (About ¥10,000~¥60,000)
- Excursion fee, graduation souvenir expenses, etc
- School supplies fee (About ¥10,000~ ¥20,000 a year)
- School expenses for newly enrolled student (1st & 6th grader of elementary school, 3rd grader of junior high school. (About ¥50,000~ ¥60,000)
